### THE ADMINISTRATIVE GUIDE FOR ANNUAL GENERAL MEETING OF A-RANK BERHAD

Day, Date and Time : Tuesday, 5 December 2023 at 10:00 am  
Meeting Venue and Platform : TIIH Online website at <https://tiih.online> or <https://tiih.com.my> (Domain registration number with MYNIC: D1A282781) provided by Tricor Investor & Issuing House Services Sdn Bhd (“**Tricor**”) in Malaysia

The meeting platform of the Annual General Meeting (“**AGM**”) is strictly for the purpose of compliance with Section 327(2) of the Companies Act 2016 and the Guidance and FAQs on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia which was further revised on 7 April 2022. Shareholders/proxy(ies) will not be allowed to attend the AGM in person on the day of the AGM of the Company. With the Remote Participation and Voting (“**RPV**”) facilities, you may exercise your right as a member of the Company to participate (including the right to pose questions to the Board of Directors and/or Management of the Company) and vote at the AGM. Alternatively, you may also appoint the Chairman of the Meeting as your proxy to attend and vote on your behalf at the AGM.

#### REMOTE PARTICIPATION AND VOTING (“**RPV**”) FACILITIES

The RPV facilities are available on Tricor’s **TIIH Online** website at <https://tiih.online>.

Members are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, “**participate**”) remotely at the AGM using RPV facilities from Tricor.

Kindly refer to Procedures for RPV as set out below for the requirements and procedures.

Please note that only members whose names appear on the Record of Depositors as at 28 November 2023 shall be entitled to participate or appoint proxies to participate on his/her behalf at the AGM.

## PROCEDURES TO REMOTE PARTICIPATION AND VOTING VIA RPV FACILITIES

Please read and follow the procedures below to engage in remote participation through live streaming and online remote voting at the AGM using the RPV facilities:

### Before the AGM Day

Procedure	Action
(i) Register as a user with TIIH Online	<ul style="list-style-type: none"> <li>Using your computer, access to website at <a href="https://tiih.online">https://tiih.online</a>. Register as a user under the "e-Services" select "<b>Create Account by Individual Holder</b>". Refer to the tutorial guide posted on the homepage for assistance.</li> <li>Registration as a user will be approved within one (1) working day and you will be notified via e-mail.</li> <li>If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.</li> </ul>
(ii) Submit your request to attend AGM remotely	<ul style="list-style-type: none"> <li>Registration is open from Friday, 3 November 2023 until the day of the AGM on Tuesday, 5 December 2023. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the AGM to ascertain their eligibility to participate the AGM using the RPV.</li> <li>Login with your user ID (i.e. e-mail address) and password and select the corporate event: <b>(Registration) A-RANK BERHAD AGM 2023</b></li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select "Register for Remote Participation and Voting".</li> <li>Review your registration and proceed to register.</li> <li>System will send an <b>e-mail to notify</b> that your registration for remote participation is received and will be verified.</li> <li>After verification of your registration against the Record of Depositors as at 28 November 2023, the system will send you an e-mail on or after 3 December 2023 to approve or reject your registration for remote participation.</li> </ul> <p><u>Note:</u></p> <ul style="list-style-type: none"> <li>Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV.</li> <li>Company and Tricor will not guarantee registration of new user and registration for RPV will be approved on time if the registration is submitted on the day of AGM.</li> </ul>

### On the AGM Day

Procedure	Action
(i) Login to TIIH Online	<ul style="list-style-type: none"> <li>Login with your user ID and password for remote participation at the AGM at any time from 9:00 a.m. i.e. 1 hour before the commencement of meeting at 10:00 a.m. on Tuesday, 5 December 2023.</li> </ul>
(ii) Participate through Live Streaming	<ul style="list-style-type: none"> <li>Select the corporate event: <b>(Live Stream Meeting) A-RANK BERHAD AGM 2023</b> to engage in the proceedings of the AGM remotely.</li> <li>If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will try to respond to questions submitted by remote participants during the AGM. If there is time constraint, the responses will be published on the Company's website within 30 days from the date of the meeting.</li> </ul>
(iii) Online remote voting	<ul style="list-style-type: none"> <li>Voting session commences from 10:00 a.m. on Tuesday, 5 December 2023 until a time when the Chairman announces the end of the session.</li> <li>Select the corporate event: <b>(Remote Voting) A-RANK BERHAD AGM 2023</b> or if you are on the live stream meeting page, you can select "<b>GO TO REMOTE VOTING PAGE</b>" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>
(iv) End of remote participation	<ul style="list-style-type: none"> <li>Upon the announcement by the Chairman on the conclusion of the AGM, the Live Streaming will end.</li> </ul>

### Note to users of the RPV facilities:

Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.

The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

### Entitlement to Participate and Appointment of Proxy

Only members whose names appear on the Record of Depositors as at 28 November 2023 shall be eligible to attend, speak and vote at the AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.

In view that the AGM will be conducted on a fully virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Proxy Form.

If you wish to participate in the AGM yourself, please do not submit any Proxy Form for the AGM. You will not be allowed to participate in the AGM together with a proxy appointed by you.

Accordingly, proxy forms and/or documents relating to the appointment of proxy/corporate representative/attorney for the AGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than Sunday, 3 December 2023 at 10:00 a.m. being not less than forty-eight (48) hours before the time appointed for holding the AGM or adjourned general meeting at which the person named in the appointment proposes to vote:

(i) In hard copy form

In the case of an appointment made in hard copy form, this proxy form must be deposited with Tricor at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or alternatively, its Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur ("**Tricor's Office**").

(ii) By electronic means via facsimile

In the case of an appointment made by facsimile transmission, this proxy form must be received via facsimile at 03-2783 9222.

(iii) By electronic means via email

In the case of an appointment made via email transmission, this proxy form must be received via email at [is.enquiry@my.tricorglobal.com](mailto:is.enquiry@my.tricorglobal.com).

For options (ii) and (iii), the Company may request any members to deposit original executed proxy form to Tricor's Office before or on the day of meeting for verification purpose.

(iv) By electronic form via TIIH Online

All members can have the option to submit proxy forms electronically via TIIH Online and the steps to submit are summarised below:

Proceed with submission of the proxy form	<ul style="list-style-type: none"><li>After the release of the Notice of Meeting by the Company, login with your user name (i.e. email address) and password.</li><li>Select the corporate event: <b>A-RANK BERHAD AGM 2023 – “Submission of Proxy Form”</b>.</li><li>Read and agree to the Terms and Conditions and confirm the Declaration.</li><li>Insert your CDS account number and indicate the number of shares for your proxy(ies) to vote on your behalf.</li><li>Appoint your proxy/proxies and insert the required details of your proxy/proxies or appoint the Chairman of the Meeting as your proxy.</li><li>Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide on your votes.</li><li>Review and confirm your proxy(ies) appointment.</li><li>Print the form of proxy for your record.</li></ul>
<b>(ii) Steps for corporation or institutional members</b>	
Register as a User with TIIH Online	<ul style="list-style-type: none"><li>Access TIIH Online at <b>https://tiih.online</b>.</li><li>Under e-Services, the authorised or nominated representative of the corporation or institutional member selects “<b>Create Account by Representative of Corporate Holder</b>”.</li><li>Complete the registration form and upload the required documents.</li><li>Registration will be verified, and you will be notified by email within one (1) to two (2) working days.</li><li>Proceed to activate your account with the temporary password given in the email and re-set your own password.</li></ul> <p>Note: The representative of a corporation or institutional members must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact Tricor if you need clarifications on the user registration.</p>
Proceed with submission of the proxy form	<ul style="list-style-type: none"><li>Login to TIIH Online at <a href="https://tiih.online">https://tiih.online</a>.</li><li>Select the corporate exercise name: <b>A-RANK BERHAD AGM 2023 – “Submission of Proxy Form”</b>.</li><li>Agree to the Terms &amp; Conditions and Declaration.</li><li>Proceed to download the file format for “<b>Submission of Proxy Form</b>” in accordance with the Guidance Note set therein.</li><li>Prepare the file for the appointment of proxies by inserting the required data.</li><li>Proceed to upload the duly completed proxy appointment file.</li><li>Select “<b>Submit</b>” to complete your submission.</li><li>Print the confirmation report of your submission for your record.</li></ul>

- A member who has appointed a proxy or attorney or corporate representative to participate at the AGM via RPV facilities must request his/her proxy to register himself/herself for RPV at the TIIH Online website at <https://tiih.online>.

## POLL VOTING

The voting at the AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of online voting.

Members/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from 10:00 a.m. on Tuesday, 5 December 2023 but before the end of the voting session which will be announced by the Chairman of the Meeting. Kindly refer to “**Procedures to Remote Participation and Voting via RPV Facilities**” provided above for guidance on how to vote remotely via TIIH Online.

Upon completion of the voting session for the AGM, the Independent Scrutineers will verify the poll results followed by the Chairman’s declaration whether the resolutions are duly passed.

## PRE-MEETING SUBMISSION OF QUESTIONS

The Board recognises that the AGM is a valuable opportunity for the Board to engage with members. In order to enhance the efficiency of the proceedings of the AGM, members may in advance, before the AGM, submit questions to the Board of Directors via Tricor’s TIIH Online website at <https://tiih.online>, by selecting “**e-Services**” to login, post your questions and submit it electronically no later than Sunday, 3 December 2023. The Board of Directors will endeavor to address the questions received at the AGM.

## NO RECORDING OR PHOTOGRAPHY

STRICTLY NO voice and/or video recording or photography of the AGM proceeding is allowed.

## NO DOOR GIFTS/FOOD VOUCHERS

There will be no distribution of door gifts or food vouchers for participating the AGM.
